ANNOUNCEMENTS

The President was pleased to introduce the incoming President, Dr. Lesley Lovett-Doust. Dr. Lovett-Doust will commence her new duties on July 1, 2009 and the President indicated that the transition will be as seamless as possible.

The President noted that applications numbers from high school applicants are down by 9%. Of particular concern is the drop in the number of applications from local students. Non-high school applications have increased. At the request of the President, Senator Robinson, Registrar explained that a call campaign was currently underway. This campaign was being conducted by students who call all applicants and answer any of their questions. Senator Robinson also noted that March UpClose will be another opportunity to showcase Nipissing University. Converting applicants to registrants will be crucial to offsetting the decrease in applications.

The President commented on recent discussion at the Council of Ontario Universities. As can be expected, the economy is the main topic. The province has given notice that there will be no additional

operating funds. Infrastructure funds may be available. On the federal side, \$2.0 B has been set aside for post secondary institutions.

The President reminded senators that the two sources of revenue for universities are tuition and BIUs. When applications are down, attempts must be made to increase revenue. The President stressed that any cuts that are to be made will be done effectively without destroying what Nipissing does well. He added that universities across the province are encountering problems in pensions, endowments and the general cost of doing business.

The Centennial Celebrations kicked off this week with a number of activities and the President thanked the committee for their hard work. He also reminded senators of a number of upcoming events including the National Volleyball championships, the Dave Marshall Leadership Awards and the International Food Fest this Saturday.

Vice-President Academic and Research was delighted to announce that Nipissing University has been awarded an additional Tier II CRC. This will be a third CRC chair and Senator Ricketts noted that the university has the freedom to choose the discipline. Contributing to this additional CRC chair is the fact that our external research funding has increased significantly these past few years.

The Vice-President also reported that the MSc proposal in Mathematics has been submitted to OCGS in time for their early January meeting. The next phase is the full appraisal phase.

The Search Committee for the Dean of Education has short listed three candidates. These candidates will be making presentations to the faculty and staff of the Faculty of Education on February 11, 12 and 13.

The Vice-President reminded senators of the second annual undergraduate research conference on the weekend of March 27 and 28. This conference is being coordinated by Genevieve deBruyn. Faculty are encouraged to attend to support their students in this unique endeavour.

The Vice-President of Finance and Administration announced that there is still work being done on the 2009-10 budget. She also indicated that the university is looking toward starting a section of the Masters of Education program in Brantford.

The Dean of Applied and Professional Studies announced that Dr. David Hemsworth is the recipient of a \$348K CIHR grant. He also reported that nursing student Alexandra Instance won the "Women of Influence" award. This award goes to a female student that combines outstanding skills in athletics and academics.

The Dean of Arts and Science indicated he had visited Manitoulin Island last Friday to discuss offering courses in Ojibwe. He also noted that the Master of Arts in History has potentially 15 candidates, including its first applicants outside of Nipissing University.

The Dean of Education reported that the Ontario College of Teachers Accreditation team had the opportunity to complete its review of all concurrent, consecutive and Aboriginal education programs. It also conducted an initial review of the Algonquin and Ojibwe degrees. Senator Wideman thanked all faculty members who worked on the exhibits room and the written submission.

The NUSU President announced the results of the recent elections for the 2009-2010 student union executive: Marianne Den Haan, President; Anna Fitzsimmons, Vice-President External; Ryan Lahti,

Vice-President Internal; and Trina Prince, Vice-President Student Life. Senator Fortier also reminded senators of the National Volleyball Championships from March 12 to 14, 2009.
