Dan Walters, as chair of Faculty Council, followed up with the following summary of the conversation at Faculty Council as Rationale for the motion:

The Senate By-laws Article 10.1 (b) outlines the terms of reference for Faculty Councils; subsection iii states that faculty councils can *make recommendations to Senate, or to an appropriate Senate standing committee on any matter deemed to be of relevant academic concern to the University.* First, the A&S Faculty council deem the restructuring of departments to be a relevant academic concern to the University. Second, A&S Faculty council argues that the process for changing the departmental structure was not followed. Under the Nipissing University Act, Article 22.2(a) the powers of Senate include making *recommendations to the Board respecting the establishment, maintenance, modification or termination of organizational structures such as faculties, schools, institutes, departments, or chairs within the University.* A&S Faculty council argues that without a recommendation from Senate to the Board, the modification of departments did not follow the correct procedures. As such, the A&S Faculty Council put forth a motion for Senate to consider, and recommend or not recommend, the departmental modifications listed above. Third, the A&S Faculty council suggest that the process did not follow the spirit of collegial governance as set out in the Report of the Special Governance Commissions by ignoring the departmental votes against the restructuring.

Members of the Senate Executive Committee voted unanimously that the motion be referred to the Joint Committee to be considered along with the original motion of July 14, 2023. Members were satisfied that the procedural questions raised in the original motion pertain to the motion(s) presented here.

Senate will address this motion when information is communicated from the Joint Committee. Once direction has been provided, Senate can receive it and give the question due consideration, providing everyone with the information required to make an informed decision.

# **Business Arising From the Minutes of June 26, 2023**

Motion: Moved by C. Richardson, seconded by D. lafrate that Senate approve that the

following statement be removed from the Bachelor of Arts, Bachelor of Science,

and Bachelor of Fine Arts degree requirements:

"Must successfully complete <u>ACAD 1601</u> within the first 60 Nipissing credits. <u>ACAD 1601</u> will count towards three credits of the Humanities (Group I) requirement."

Following a lengthy discussion including the pros and cons of removing the ACAD 1601 course requirement, a request for a secret ballot was made. As there was no way to ensure confidentiality during the meeting for the on-line Senators, it was decided that an email including an anonymous Microsoft Forms poll be sent to only those Senators in attendance in-person and on-line. The results of the poll were announced by email following the vote. The motion was DEFEATED.

As noted in the July 6, 2023 Senate Executive Committee Report, as per Senate By-laws Article 7.5(c), the request that the motion be moved to conduct a secret ballot should have been moved, seconded, and put forward for a vote. Members of the Senate Executive Committee acknowledged this oversite and were satisfied that the minor procedural detail was addressed and considers the vote to be legitimate. It was noted that the Senate By-laws will be followed for future such requests.

#### **Reports From Other Bodies**

The Provost and Vice-President Academic (PVPA) provided a written report. The report is attached to the minutes. She advised that President Wamsley was participating in a PhD defence and unable to attend Senate.

#### **Question Period**

In response to concerns expressed regarding amendments to Bill 26 – Strengthening Post-secondary Institutions and Students Act, 2022, the PVPA advised that the policy is still under review and feedback is being received with respect to the provisions in the policy. In regard to investigation and support, privacy considerations are being looked at and research is ongoing. The feedback that has been received has been integral in developing a strong policy.

As a preamble, the Nipissing University Act, Article 22, Duties of the Senate (22.1), was quoted: "The Senate shall establish the educational policies of the University and may make recommendations to the Board with respect to any matter of academic concern to the University."

The following concerns were raised:

- the Biology/Chemistry and Geography departments do not support the merger
- the mergers took place with little to no faculty consultation
- department votes against the mergers were not respected and ignored
- the mergers are in violation of the Nipissing University Act
- significant cost savings were not identified
- no criteria for merging the departments was provided, i.e.: number of faculty and students
- there are no synergies that support the merging of the departments
- several departments currently do not have a Chair
- upcoming faculty retirements, members on leave and cross appointments
- upcoming IQAP program reviews
- program Chairs having to field questions from students about program requirements in which the Chair has no academic background or knowledge
- it was a Senate responsibility to make these decisions

In response to the concerns expressed, the Dean of Arts and Science advised that the rationale had been discussed at previous Senate meetings, and that the mergers are not all about cost savings. The mergers are part of a regrouping strategy and the groupings do have an academic alignment. From an academic programing perspective there is a lot of overlap of content and synergies to deliver degree programs. He advised that there were 15 Chairs and a disproportionate distribution of students. The initiative undertaken over the last 18 months was to work together to develop a more efficient organizational structure in respect to addressing enrollment issues.

The PVPA expressed a procedural concern about what was voted on today and given the complexity of Motion 4, suggested that the motion should have been provided as a notice of motion.

She advised that her understanding is that the intention of the motion is that **the process for coupling** or other mechanisms to reorganize academic units will be discussed at the Joint Committee so that it aligns with the expectations of the NU Act. If a process can be found that satisfies everyone then there could be a host of ways in which we could work cooperatively and collaboratively. The Joint Committee can provide a framework moving forward under the assumption that departmental combination may be necessary and advise what this will look like and how these conditions, as well as the needs of individuals who may not have an understanding as to how other department operate, can be satisfied. She expressed concerns in respect to ongoing student supports and how these functions will be fulfilled and students advised. Decisions about structure should be taken deliberately, as they are not simple to reverse.

In response to the PVPA's comments, it was noted that the Joint Committee will review the process on the question of jurisdiction, authority, and procedure. The goal is to define a path forward recognizing that there are ongoing questions about whether the process followed in the last academic year aligned with the spirit or the letter of the NU Act, and whether the unit mergers had been approved by Senate by virtue of being reported to Senate from a delegated committee. Given the specific nature of the changes to structure that were adopted, it is necessary to highlight that Senate is not in a position to make these decisions on its own and must work in collaboration with the Board of Governors. The Joint Committee is to perform this work.

The following motion was put forward for recommendation to the Joint Committee of the Board and Senate to be discussed as a collegial body:

Motion 4: Moved by G. McCann, seconded by D. Tabachnick that whereas the merger of Biology/Chemistry and Geography was not supported by their respective faculty members, and whereas no sufficient rationale was provided prior to this decision, that the merger be tabled pending discussion by the Joint Committee of the Board and Senate.

**CARRIED** 

The NUSU President requested that it be noted in the minutes that NUSU supports this motion. He advised that he met with the President of the Biology Society as well as the President of the Geography Club to receive input on the students' thoughts regarding the merger. Prior to his meeting with the students, they had completed a petition against the merger. He reminded that the merger is not only a faculty concern, it is also a student concern.

# Board of Governors Meeting June 27, 2023

The Board of Governors met on June 27, 2023, in the President's Boardroom (F303) and via Zoom remote conferencing, where "Pathways: Our Commitments to Water, Land and People," the 2024-2029 Nipissing University Strategic Plan was presented and subsequently approved.

To meet a recommendation from the Auditor General's report, the Board approved revisions to the Capital Debt Policy. The policy is intended to define the responsibilities for the approval of new external debts, maximum limits of external debt and reporting on capital debt. All Board-approved policies are available for viewing on the Nipissing University website.

Recommendations to appoint the following Individuals to the Research Ethics Board:

- Dr. Anahita Baregheh, Associate Professor, Faculty of Education and Professional Studies (3-year term – July 2023, renewable);
- **Dr. Christine Lalonde**, Instructor, Graduate Studies and Research (3-year term July 2023, renewable);
- Dr. Adam Davis, Canadore College (3-year term, renewable); and
- **Dr. Anna-Liisa Mottonen**, Canadore College (3-year term, renewable).

#### **ACAD 1601**

At the last Academic Senate there was a motion on the agenda seeking to eliminate ACAD 1601 as a degree requirement for BA, BSc, and BFA students. NUSU was opposed to this motion for two main reasons: Firstly, we believed that ACAD 1601 as a degree requirement is highly beneficial to the vast majority of students who take it, such as guiding students in accessing library resources. This is especially true given the anticipated large intake of first-year students whose high school years were interrupted by Covid-19. Secondly, we believed that there had not been enough consultation with the ACAD professors as well as steps moving forward in lieu of ACAD 1601 being a degree requirement. While NUSU acknowledges that ACAD 1601 would still be available to students, and some majors could keep ACAD 1601 as a requirement, we believe the widespread requirement part was of the utmost importance.

Our hope moving forward is that the University will have a tripartite response to the failure of this motion, being that they will reassess ACAD 1601 in our current and unprecedented academic landscape; consult robustly with the ACAD 1601 professors (while recognizing the conflict of interest); and, consider a specialized ACAD course (still as a degree requirement) that caters specifically to certain programs.

#### REPORT OF THE SENATE EXECUTIVE COMMITTEE

August 3, 2023

A meeting of the Senate Executive Committee took place in person and by Zoom conference on August 3, 2023.

The purpose of the meeting was to set the agenda for the August 11, 2023 Senate meeting.

The Provost chaired the meeting until President Wamsley was able to attend.

Under business arising from the minutes of the July 14, 2023 Senate meeting, it was noted that the June 26, 2023, Senate minutes were amended to include the four questions regarding the removal of the ACAD 1601 course requirement. The amended minutes will be posted to the Senate website.

It was noted that an election for two members of the Joint Committee of the Board and Senate on Governance is included in the agenda. One Senator was elected at the July 14 Senate meeting, but a member of the Joint Committee resigned therefore two faculty Senator representatives will be required. The Joint Committee is being convened to address the motion put forward for recommendation regarding the proposed merger of the Biology/Chemistry and Geography departments.

A motion passed at the July 26, 2023 Arts & Science Faculty Council meeting requesting that Senate recommend or not recommend the list of departmental mergers was received for inclusion in the Senate agenda. Concerns were expressed that as no report, recommendation or rationale was included with the motion that Senators who aren't members of these departments may not have sufficient knowledge to make an informed decision. Members agreed that it would not be appropriate for Senate to consider the motion when a recommendation has already been referred to the Joint Committee.

It was noted that many procedural process questions were raised by the mergers. The motion under discussion is an example of the concerns that Senate will be asked to deal with once the Biology/Chemistry and Geography questions are dealt with. A process will need to be established by which Senate can formally make recommendations to the Board on questions of restructuring.

Members of the Senate Executive Committee voted unanimously that the motion be referred to the Joint Committee to be considered along with the original motion of July 14, 2023. Members were satisfied that the procedural questions raised in the original motion pertain to the motion(s) presented here.

Senate will address this motion when information is communicated from the Joint Committee. Once direction has been provided, Senate can receive it and give the question due consideration, providing everyone with the information required to make an informed decision.

A request was made that future electronic votes in Senate using Microsoft Forms allow for multiple Senators to see and review the votes and results. Votes would still be anonymous but there would be an observer or an adjudicator for transparency. This would allow more confidence in the process as further voting may arise.

The following elections were provided to the Senate Executive Committee for inclusion in the Senate agenda:

- Joint Committee of the Board and Senate on Governance (two faculty Senators)
- Senate Budget Advisory Committee (one faculty Senator)

All positions are for three-years terms effective July 1, 2023 to June 30, 2026.
