### Welcome to the Nipissing On-campus BScN Program Class of 2029!

We are pleased you have chosen to embark on this exciting journey in the discipline of nursing with us. Nursing is a versatile, rewarding, and in-demand profession. Throughout the next four years, we will work together to contribute to your success as a baccalaureate-prepared Registered Nurse. In advance of this, there are requirements that all BScN students must meet.

It is mandated by the Ontario Hospital Association (OHA) that all nursing students complete a Communicable Disease Screening Form (CDSF) at the beginning of the program and update it annually thereafter. Students will submit all clearance documents through the School of Nursing Clearance Website. Your completed CDSF, supporting documents, and all other required documentation must be uploaded to the School of Nursing Clearance Website no later than September 29, 2025. A link to the clearance website will be emailed to you over the summer no later than July 2, 2025. If you have any questions about clearance documents, please contact the Clinical Placement Clerk by email to [clinicalclearance@nipissingu.ca](mailto:clinicalclearance@nipissingu.ca).

The required documentation includes, but is not limited to, the following:

- Basic Cardiac Life Support (BCLS) or (BLS) – Level “C”, Health Care Provider (HCP) – First Aid is NOT required
- N95 Mask Fit
- Ministry of Labour Worker Health & Safety Awareness in Four Steps certificate

Many clinical placement agencies require proof of COVID vaccinations. Students must provide this proof to be permitted into clinical placements to continue in the BScN program.

The Regulated Health Professions Act and the Nursing Act of Ontario mandate that persons who wish to register as a nurse must be Canadian citizens, permanent residents of Canada, or authorized under the Immigration Act. In addition, they may NOT have a previous criminal conviction and NOT have been subject to a previous disciplinary proceeding, where a license was revoked, in another health profession (or in nursing from another jurisdiction) resulting from incompetence, misconduct, or incapacity. Furthermore, all clinical agencies require a Police Vulnerable Sector Check prior to beginning clinical practice. These checks are required for our program and are the responsibility of the student. A Consent to Disclosure Letter will be emailed to you over the summer.

There will be a New Student Orientation (NSO) in the near future. This is an opportunity to learn more about the exciting program you are entering as well as meet faculty and fellow matriculating students. Details for this are outlined elsewhere in this package.
