

## EXECUTIVE SUMMARY & IMPLEMENTATION PLAN

Under Nipissing University’s Institutional Quality Assurance Process (IQAP) and the Ontario Universities Quality Assurance Framework (QAF), all programs are subject to a comprehensive review at least/at minimum every eight years to ensure that they continue to meet provincial quality assurance requirements and to support their ongoing rigour and coherence. This review was conducted under the terms and conditions of the IQAP approved by Senate on June 29, 2023 and ratified by the Quality Council on May 5, 2023

In academic years 2022-23 a program review was scheduled for BA and BSc in Psychology. This was the 2<sup>nd</sup> program review for this program. The timeline of the review was as follows.

### A. REVIEW SUMMARY

**Two external reviewers conducted the review. During the in-person site visit, the reviewers met with the following groups and individuals:**

- Provost and Vice President, Academic
- Dean and Associate Dean of Arts and Science
- Registrar and Associate Registrars
- Internal Review Committee
- Members of Psychology Department
- Current Students

**The academic programs offered by the Department which were examined as part of the review included:**

Bachelor of Science – Psychology

Bachelor of Arts – Psychology

**The following program strengths were noted:**

Faculty demonstrated exceptional dedication to student engagement, including personalized support and involvement in research collaborations with undergraduates. This commitment was highly valued by students.

**Summary of review team recommendations:**

The reviewers advised the department to hold a facilitated retreat focusing on strategic planning, curriculum review, and program development including graduate programming. They recommended hiring at least two tenure-track faculty to replace retirees and strongly suggested a third position for program diversification, such as incorporating Indigenous content. The department should consider alternative advanced statistics courses to retain students, explore interdisciplinary programming, continue major modifications to the BSc degree, and increase special topics offerings at the 4000 level. Collaboration with recruitment efforts to attract students was also emphasized.
